Crystal Pool

On September 6, Council received a staff <u>report</u> regarding parking at the proposed new Crystal Pool. Council resolved to:

- 1. Direct staff to <u>consult with stakeholders and residents from the North Park neighbourhood</u> on neighbourhood street parking options associated with a distributed parking approach; and
- 2. Approve \$40,000 to be funded from 2018 Contingencies, to complete an investigation of underground parking options in Central Park and/or modular parking on the Save on Food Memorial Arena Parking lot.

On October 4, Mayor Helps and Councillor Loveday will present a report and make a recommendation:

• That Council direct staff to work in partnership with the North Park neighbourhood and the broader community to co-develop a plan for a consultation process for Central Park including mitigation of the impacts of pool construction on park users, plans for the future of Central Park, and land use issues related to the new pool and that this consultation planning take place this fall as staff are out in the neighbourhood engaging on parking options.

Storage for Homeless' Belongings

At their October 4 meeting, Council will receive a <u>report</u> and Council member motion proposing to release funds set aside for Our Place Society to build and manage a storage space for those experiencing homelessness.

Last Call for Neighbourhood Grants

Inclusionary Housing and Density Bonus

At their September 6 Committee meeting, Council received a <u>staff report</u> and approved the draft Inclusionary Housing and Density Bonus Policy to take effect no later than March 31, 2019.

Amendments included:

- A cash contribution of \$200,000 per affordable housing unit may be considered in lieu of the delivery of on-site affordable rental units, where projects deliver less than 20 net new strata units
- Staff are directed to undertake further consultation with stakeholders

- Adopt the updated affordable housing targets and levels of affordability to guide community amenity contribution negotiations and incorporate these in the Victoria Housing Strategy
- Direct staff to further <u>explore pre-zoning by consulting with stakeholders, including the Community Association Land Use Committees</u>, Victoria Civic Heritage Trust and other interested community stakeholders
- That staff report back twelve (12) months following adoption of the policy with information on: (a) the impacts on new developments; (b) total amenities received, identified by value and type; and (c) recommendations for any potential revisions to the policy
- That the Development Summit this year be called the Housing Summit
- Flag for further discussion and research whether the 3 bedroom allocation at 5% is sufficient

Tenant Assistance Policy

Beginning September 1, a new <u>Tenant Assistance Policy</u> provides guidelines for tenant assistance when renters are required to move because their building is being redeveloped. The Tenant Assistance Policy is one of several initiatives the City of Victoria is undertaking as part of its <u>Housing Strategy</u>. Cannabis Consumption Sites

At their September 6 meeting, Council approved a motion:

- That staff be directed to investigate, beginning in the first quarter of 2019, regulations in other jurisdictions governing consumption sites for cannabis use.
- That this review take into consideration the City and County of Denver, Colorado's Cannabis Consumption Pilot Program, as well as the regulatory context in the City of Victoria arising from regional, provincial and federal regulations.
- That staff report back to Council on the advisability of initiating a Pilot Program or introducing regulations for consumption sites for cannabis use.
